

CERTIFICATE OF FINANCIAL RESPONSIBILITY (CFR)

One of the regulatory requirements for issuing the document for a student visa is that credible documentation of sufficient finances be on fle with the school. You have two options to demonstrate available funds from a savings and/or checking accounts. Proof of funds cannot be more than six months old when the I-20 is processed.

- 1. *A bank official may complete and sign the bank section at the bottom of the CFR to certify that funds are available in the specified account (preferred).
- 2. If the bank cannot sign the CFR, attach an official bank letter/statement with an official signature and stamp.
